Administrator Michael Beasley was present. Town Clerk Kayla Jerkins was in attendance. Attorney Thomas Boulware was in attendance.

Mayor Williams called to the meeting to order, and he stated that there was a quorum.

Councilmember Odermatt led the invocation. Councilmember Collins led the Pledge of Allegiance to the American Flag.

Mayor Williams welcomed everyone to the meeting.

Mayor Williams asked for a motion to approve the agenda. Councilmember Odermatt made a motion to approve the agenda with the omission of Line Item #12: Event Presentation, due to the presenter not being present. Councilmember Valentine seconded the motion. All were in favor and the motion carried.

Mayor Williams asked for a motion to approve the July 10th Regular Meeting minutes. Councilmember Moody made a motion to approve the July 10th Regular Meeting minutes. Councilmember Odermatt seconded the motion. All were in favor and the motion carried.

Mayor Williams asked Police Chief Gainey if the police department could help with the event. Police Chief Gainey said agreed to help with the event. Mayor Williams asked for an approval to accept the homecoming parade. Councilmember Tyler made a motion to approve the homecoming parade. Councilmember Moody seconded the approval. All were in favor and the motion carried.

Mayor Williams said the homecoming committee is requesting a pep rally to be held in front of Meeting on Main and the Post Office. Mayor Williams said he spoke with Meeting on Main and Rodney Brown. If the pep rally is held at the desired place, then the road would have to be shut down for two days.

Councilmember Tyler said the homecoming committee wants to get the community involved and give the community a boost to get excited.

Councilmember Moody said that Meeting on Main would have to shut down during the event. Councilmember Moody said every time there is another event it is on a Saturday.

Councilmember Odermatt agreed with Administrator Beasley.

Councilmember Collins said events are usually on a Saturday when the business is closed.

Mayor Williams said the business is just worried about parking. Mayor Williams said they won't approve of the event just yet and said the committee is meeting on the 6^{th} of September and the 12^{th} of September.

<u>Line Item #14 Police Department Update</u>

Police Chief Gainey thanked the council for their support. Police Chief Gainey said they had one officer leave the Town of Williston and one certified officer came to fill the spot. Chief Gainey said the force is working with some burglary and larceny cases of people breaking into sheds and stolen lawn equipment. Chief Gainey said that Captain Kaney has been writing citations for yards needing to be cleaned up and has gotten positive responses. Chief Gainey said in August- July of 2021-2021 there have been 285 cases, from August- July of 2022-2023 there have been more than triple with 835 cases the force has been working on.

Mayor Williams told Chief Gainey that they appreciate the officers. Mayor Williams said an email has been sent to the county for road and sidewalk clean ups.

Line Item #15: Approval to Hire

Administrator Beasley said that a spot needs to be filled for Mark Carroll who retired. Administrator Beasley introduced Dennis Williams. Administrator Beasley said he has an opportunity to get his license and would like to hire him and for him to start tomorrow.

Mayor Williams asked for a motion to hire Dennis Williams to fill Carroll's place.

Councilmember Odermatt made a motion to approve the hire of Williams. Councilmember Valentine seconded the motion. All were in favor and the motion carried.

Line Item #16: Administrator's Report

Administrator Beasley and Town Clerk Jerkins are looking at charges the town is paying for and are changing some companies so the town can save around \$20,000 a year. Administrator Beasley welcomes the new public works director. Administrator Beasley said the director can evaluate the department and hire if need be. Administrator Beasley said the beautification committee meets at 5pm before coming to the Council Meetings. Administrator Beasley said the Recreation Department's football season is approaching and they are working hard to find the numbers. Administrator Beasley told Chief Gainey he appreciates all their hard work, and it is rare to find a full staff.

Mayor Williams asked the council if they had any questions.
